### TERMS AND CONDITIONS FOR GRANTING OF SUBVENTIONS FOR CARNIVAL 2011

**WHEREAS** the Government of Grenada has found it necessary to provide certain funds (herein called “the subvention”) to various organization to assist these organization with the staging of events associated with Grenada’s Carnival 2011 (hereinafter referred to as “Spicemas 2011”)

**AND WHEREAS** the subvention will be provided to the organization through the Grenada Carnival Committee (herein referred to as “GCC”) a Government appointed committee with the responsibility of managing Spicemas 2011.

**AND WHEREAS** the subvention shall be provided to the organization which make up ----- (herein referred to as -----“) upon the terms and conditions hereinafter contained.

**IT IS HEREBY AGREED** as follows:

#### 1. Amount of the Subvention

1.1 A sum of EC\$ \_\_\_\_\_ shall be provided to ----- (herein referred to as “the Organization”) to assist the Organization’s production for Spicemas 2011

#### 2. Qualification for Subvention

2.1 ----- shall submit to the GCC a list of all registered Mas Bands/ Tents/ Steelbands for Spicemas 2011 and the respective Mas Bands/ Tents/ Steelbands leaders.

2.2 For Mas Bands/ Tents/ Steelbands to qualify for a subvention they must be registered with ----- /GCC.

#### 3. Conditions for grant of the Subvention

3.1 The provision of the subvention is made on the understanding that its value will not be increased and is granted for a specific purposed herein contained. Under no circumstances is the subvention to be used to meet cost incurred by any other project or activity of the organization.

3.2 The Organization hereby undertakes that it will participate in the events of Spicemas 2011. Should the organization not participate in Spicemas 2011 after receiving the subvention, the Organization’s leader and/or such other person(s) responsible for the Organization will be held liable to repay the subvention disbursed to the Organization by GCC.

3.3 At the conclusion of Spicemas 2011, the Organization shall submit to the GCC a detailed accounts report with supporting receipts, verifying how the subvention was expended. This report must be submitted on or before the 15<sup>th</sup> September 2011.

3.4 Should the Organization fail to submit the said report, the organization shall be liable to refund such part of the subvention that is unaccounted for and the Organization shall not be eligible to receive a subvention in the following year to assist it in staging of carnival events.

4. **Governing Laws**

4.1 These Terms and conditions for the granting of the subvention in all respects will be governed by and construed in accordance with the laws of Grenada.
